Ms. Boitumelo Mosako
Chief Financial Officer, Development Bank of Southern Africa

Ms. Boitumelo Mosako is the Chief Financial Officer and an Executive Board member of the Development Bank of Southern Africa (DBSA). The DBSA has a mandate to finance infrastructure projects in the Transport, Energy, Information and Communication Technologies, Water and Sanitation and the social sectors including, education and health. While Boitumelo's core responsibility at the DBSA is for Strategy, Finance, Procurement and Information Technology, she also serves as a member of the Board Credit and Investment Committee of the DBSA where all new infrastructure projects entering the DBSA pipeline is reviewed for approval. Boitumelo is one of the key Executives at the DBSA driving the Agenda of the Sustainable Development Goals. She is be part of the DBSA committee reviewing the Sectoral reports for the South African SDG study the DBSA and World Bank is partnering on for South Africa with her specific focus on the Transport sector of the research.

Guangzhe Chen Global Director, Transport Practice and Regional Director, South Asia Infrastructure, World Bank

Guangzhe Chen, a Chinese national, is the Global Director for the Transport Practice in the World Bank's Infrastructure Practice Group. As Global Director, Mr. Chen provides leadership in the formulation and implementation of World Bank strategy and programs for sustainable road, urban, rail, logistics, water and air transport, and as well as key cross-cutting agenda such as road safety, climate adaptation/mitigation, gender, human capital development, disruptive technologies and financing. The Global Practice has a portfolio of approximately US\$45 billion in more than 100 countries, and about 280 staff.

From July 2019, in addition to his role as Global Director, Mr. Chen assumed the position of Regional Director for Infrastructure in South Asia region covering Afghanistan, Bangladesh, Bhutan, India, Maldives, Nepal, Pakistan and Sri Lanka. In this capacity, Mr. Chen oversees the formulation and implementation of the Transport and Energy financing and knowledge programs in the region. Prior to his current positions, Mr. Chen was the Senior Director for the World Bank's Water Global Practice from October 2016 to October 2018. Before that he served as World Bank Country Director for Ethiopia, in Addis Ababa, and subsequently for Southern Africa, covering Botswana, Lesotho, Namibia, South Africa, Swaziland, Zambia and Zimbabwe, based in Pretoria. He started at the World Bank as a task team leader and then sector manager in the transport sector, followed by serving as a sector manager in the urban, water and disaster risk management.

An economist by training, Mr. Chen has over 25 years of international experience in the field of sustainable development, infrastructure finance and management with the World Bank Group and the Asian Development Bank. Mr. Chen holds a graduate degree in Economics from Harvard University, USA, and B.A. in Economics from Zhongshan (Sun Yat-Sen) University, Guangzhou, China.

Riccardo Puliti joined the World Bank Group as Senior Director, Head of the Energy and Extractives Global Practice in November 2016. In his role, Riccardo leads a team of about 400 professionals in their work developing policies and financing in the global energy and extractive industries. The Energy and Extractives practice has a portfolio of approximately USD 40 billion. On July 1, 2019, in addition to his role as Global Director, Riccardo assumed the position of Regional Director for all Infrastructure for Africa.

Prior to joining the World Bank Group, Riccardo was the Managing Director in charge of Energy and Extractive Industries at the European Bank for Reconstruction and Development, leading a group of 100 professionals with a portfolio of approximately EUR 11 billion.

Riccardo started his career at Istituto Mobiliare Italiano in 1987 before moving to Banque Indosuez and NM Rothschild where he worked in equity capital markets, always in the energy and infrastructure sectors. During his career, Riccardo has been a nominee or independent member of the board of several energy and extractive companies, including OMV Petrom (where he chaired its Risk and Audit Committee), Interrao OJSC, Irkutsk Oil and Iberdrola Poland. He has also served as the Sector Manager for Finance & Private sector Development for West and Central Africa, as well as in other positions in MENA and WBI. Paul holds a PhD in Economics from Rennes University, Master's Degrees in Engineering and Economics from France, and a BA in Engineering from the National Advanced School of Posts and Telecom, Cameroon. He joined the Bank in 1998, coming from France Telecom (Orange Labs).







Susanna Zammataro
Director General, International Road, Federation

In her capacity as Director General of the International Road Federation (IRF) in Geneva, Switzerland, Susanna Zammataro is responsible for developing and implementing strategic plans for the IRF, whose mission is to promote the development of roads and road networks that enable access and sustainable mobility for all.

Recently named as one of the 40 Most Remarkable Women in Transport by TUMI, she is the in-house expert on sustainability and responsible for the overall environmental programs and activities run by the IRF. These include the Greenhouse Gas Calculator for road infrastructure (CHANGER) and the Green Public Procurement Initiative and Innovative Practices for Greener Roads. Member of the UNECE Climate Change Expert Group on Adaptation she is also a Steering Committee Member of the Sustainable Mobility for All initiative (SuM4AII) led by the World Bank.

Susanna is un untiring advocate for road safety. She is a member of the Advisory Board of the FIA High Level Panel on Road Safety and serving since 2012 as the Co-Chairperson of the "Safer Roads and Mobility" Pillar of the United Nations Road Safety Collaboration Group (UNRSC), a global multi-stakeholder partnership whose aim is to facilitate international cooperation and to strengthen global and regional coordination.



Gavin Dunnett
Director of Mobility, European Investment Bank

Gavin Dunnett has spent his entire professional career in the planning and implementation of major transport projects. After graduating in civil engineering, he joined renowned engineering consultant ARUP, where he undertook postgraduate studies in transport planning and economics. After completing his professional training in Scotland, he developed his career in international transport projects, including designing parts of the Thracian and Anatolian motorways in Turkey. He eventually became a regional director of ARUP and was elected as a Fellow of the Institution of Civil Engineers in 2003. After over 20 years in transport consultancy he joined the European Investment Bank as a sector specialist in transport, working on the technical due diligence of a variety of European and international transport projects, including urban tram and light rail projects in Europe, North Africa and Turkey. In 2011, he took over responsibly for the civil aviation and maritime sectors of the Bank's technical directorate before becoming overall Head of the Mobility department in 2016.







Peter Kronberg Safety Director, Volvo Group

Shantanu Mukherjee
Integrated Policy Analysis Branch (IPAB), United Nations Department of Economic and Social Affairs

Shantanu presently heads the integrated policy analysis branch in the Sustainable Development Goals Division within the UN's Department for Economic and Social Affairs (UN-DESA). He is a micro-economist with interests in poverty, health and sustainability. Apart from cross-cutting SDG analysis, a particular area of focus in his current work is enhancing the impact of science, technology and innovation in advancing sustainable development. In this capacity, his team leads the UN support for the Global Sustainable Development Report (GSDR) and the Technology Facilitation Mechanism (TFM).

Prior to this, he led the research and writing unit of the UN Development Programme (UNDP)'s Human Development Report through two report cycles. This was preceded by a stint as head of UNDP's global MDG policy work, which was marked by extensive collaborations with the World Bank and other development entities across the UN system. In that position, he worked with national planning, finance and various sector ministries in many countries in Africa, Asia and Latin America. Some of his most interesting experiences during this period were in Bangladesh, Cambodia, Indonesia, Jordan, Myanmar, Pakistan, Ghana, Togo and Yemen.

Shantanu began his career with the Indian Government in different areas of finance as well as development policy planning and implementation. He earned a PhD in Economics from Princeton University, and also holds advanced degrees in Public Policy and Physics.

Mauricio Rodas Former mayor of Quito

Mauricio Rodas is a JD from Universidad Católica de Quito. He also holds two master's degrees in Government Administration and Political Science from the University of Pennsylvania. He started his professional career with the UN's Economic Commission for Latin America and the Caribbean in Santiago de Chile and Mexico City. Later he worked as a policy consultant for the Mexican government. In 2007, he founded and served as the Executive Director of Ethos Public Policy Lab, a think tank based in Mexico ranked among the most influential in Latin America by the Global Go To Think Tank Index Report.

In 2011, Rodas returned to Ecuador and founded SUMA, a national political party. In 2013, he ran for president of Ecuador; the following year was elected as mayor of Quito (2014-2019). During his period, Rodas led the construction of the first metro line in Quito and in Ecuador. He was the hosting mayor of the UN's Conference on Urban Sustainable Development – Habitat III. He also had an active leadership role in the main city networks: two terms as world co-president of UCLG, member of the global boards of C-40 Cities Climate Leadership Group, ICLEI, and the Global Covenant of Mayors for Climate and Energy. He is a Young Global Leader and member of the Global Future Council on Cities and Urbanization of the World Economic Forum (WEF). In 2019, he was named one of the 100 Worlds' Most Influential People on Climate Action by Apolitical; he also received the University of Pennsylvania's World Urban Leadership Award.





Currently, he is a Visiting Fellow at the University of Pennsylvania where he is working on the "Cities Climate-Resilient Infrastructure Financing Initiative –C2IFI." C2IFI aims to develop a knowledge hub to consolidate information about financing opportunities for cities and facilitate access to these resources.



Karen Vancluysen Secretary General, POLIS Network.

Karen was appointed as Secretary General of Polis in September 2014, after having been the network's Research Director for 8 years. Nhan Tran
Head Safety and Mobility, World Health Organization

Dr. Nhan Tran was born in Viet Nam and grew up in the United States where he completed studies in international relations and modern languages. He obtained a graduate degree in International Public Health and a PhD in Health Systems Research with an emphasis on road traffic injuries from the Johns Hopkins University School of Public Health. Dr Tran worked at the regional and federal levels of the United States Department of Health and Human Services in various capacities managing programmes and as a science advisor. Later, as a researcher at Johns Hopkins University, Dr Tran was engaged in health systems and road safety research and helped to establish the International Injury Research Unit.

Dr Tran joined WHO in 2011. For the last 6 years, he was the Manager of the WHO Alliance for Health Policy and Systems Research where he lead the development of guidance and initiatives to facilitate the implementation and scale up of proven effective interventions. Since October 2017 Dr Tran is the Coordinator of the Unintentional Injury Prevention Team (UIP) within the Department for Management of Noncommunicable Diseases, Disability, Violence and Injury Prevention (NVI).
